-Equity Team: Alyson reported that the team is being filled, discussed the status of the equity team presentation, and finished her report by discussing the status of advocacy clubs around the district. An equity calendar will be released soon and some of the highlights were shared with the delegates.

-Labor Council: Corey discussed the history of how, in 2001, the United Workers for Local Government was formed to allow Labor Leaders to come together to discuss issues important to their members. We welcome anyone who represents working Families to join in whether affiliated with the AFL-CIO or not. We continue to meet every month with the goal of speaking with one voice and hold interviews for office under that banner every election.

We held 53 interviews over several days with a panel of over 30 affiliate leaders who came together to recommend a slate of "Labor Candidates" to their members, the Napa Solano Building and Construction Trades and our CLC that are then ratified by those organizations. That slate was distributed to site reps to review.

-Member Engagement: Alyson discussed the member engagement activities we have scheduled for 2018-2019. The focus for member engagement will be site-based activities and, in fact, members of his committee will be traveling to your school site in order to help host your first member engagement event of 2018 – with goodies. The second event will be a polluck at your site and the third one will be your decision. The report finished with some suggestions for effective member engagement activities and best practices to follow. The first off-site member engagement/mixer of 2018 will be held at El Patron on Sept 6th from 4-7. The report finished with some suggestions for off-site member engagement cards.
