



Memorandum of Understanding
Between
the Vacaville Unified School District
and
the Vacaville Teachers Association

Calendar and Work Day Provisions for 2020-2021

This MOU shall go into effect immediately and shall sunset on June 30, 2021, with both parties agreeing that as conditions change and/or the COVID19 pandemic continues beyond June 30, 2021, the parties agree to meet to extend and/or modify this MOU at any time.

Nothing in this MOU shall supersede the collective bargaining agreement, unless otherwise stated.

For the calendars, the following are defined as:

Teacher Workday Only: non-instructional day, no distance learning for students

Full Distance Learning/Teacher Workday (instructional day for students; preparation time, some staff meeting time, some collaborative time, some professional development time). In Phase 4, with full in-person classes, these days shall become instructional days and staff meetings, professional development and collaboration time shall revert back to the collective bargaining agreement.

Replace Article 20.7 with:

20.7 "Instructional Day(s)" means any day(s) pupils are present for instruction and/or expected to participate in distance learning.

Replace Article 4.3.1 with:

4.3.1 The Teacher Workdays from August 10-August 14, 2020 shall be unencumbered, except for up to thirteen (13) hours, to prepare for the upcoming school year. The last Teacher Workday of the work year shall be unencumbered. Reasonable effort shall be made by administration to efficiently utilize the encumbered time for those topics essential to the start of the school year.

There shall be no in-person Back-to-School Night (or similar) events in 2020-2021. Unit members may opt to host a live synchronous parent informational meeting.

There shall be no calendared secondary parent conferences for 2020-2021.

Parents/Guardians wishing to discuss progress of students may meet with a unit member virtually (email, phone or video conference) according to the unit member's schedule and only in person with a unit member's consent.

On any Wednesday prior to report cards being due for teachers, there shall be no Wednesday Collaboration, staff meetings and professional development mandated during the duty day.

Suspend Article 4.4.2 (Extra Short Minimum Days) unless Phase 4 is implemented at the time described by this article.

In the case of a four-day (4-day) because of a school holiday, there shall be no Wednesday Distance Learning/Teacher Workday in Phase 2, 3 and Transition to 4.

11/19-11/20/20: Phase 2/3/Transition to 4 Distance Learning/Teacher Workdays (Report Cards, Conferences as needed), Phase 1: thirty (30) minute Synchronous Learning only

12/18/20: No Minimum Day

1/13/21: Wednesday Collaboration may be held

3/9-3/10/21: No Minimum Day

3/11-3/12/21: Phase 2/3/Transition to 4 Distance Learning/Teacher Workdays (Report Cards, Conferences as needed), Phase 1: thirty (30) minute Synchronous Learning only

4/2/21: No School Holiday

Changes to the 2020-2021 Middle School Calendar (Appendix B, Section K), unless Phase 4 is implemented:

8/13-8/14/20: Teacher Workdays

All Phase 2/3/Transition to 4 Wednesdays shall be Distance Learning/Teacher Workdays, except for 9/9/20 and 1/20/21.

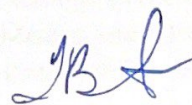
